Program Admission:

To qualify for MTC's, applicants must have:

- Fulfilled all MTC general admission requirements, and submitted both the Application and the non-academic standards form.
- Successfully completed high school or certification of equivalent education by an organization recognized by the U.S. Department of Education.
- Acceptance into the Radiography Program is contingent upon receipt of official final high school transcript or GED examination equivalent,
- Understands must have a minimum accumulative grade point average of 2.5 (4.0 scale) or equivalent from high school, or minimum 12 term credit hours or equivalent of college credit, or successful completion of GED examination.
- GPA used for admission point system will be the most recent GPA.
- Successful completion of high school algebra, biology, and chemistry, or successful completion equivalent college coursework (MTC's SCI1050A Principles of Biology and Chemistry and/or MTH099 Pre-Algebra).
- Completed Accuplacer academic placement testing with the following minimum scores: Reading ACT 20, Accuplacer 80 or successful completion of Eng 0970; Writing Act 18, Accuplacer 70 or successful completion of Eng 0990; Math (elementary Algebra) Act 19, Accuplacer 40 or successful completion of MTH 0990.
- Reached 18 years of age by the end of the calendar year in which you are seeking admission into Radiography technical courses.
- Completion of a physical examination including all diagnostic screenings (with results on file) prior to entering the first Radiography clinical course.
- Observation in a(an) Imaging Department(s) a minimum of thirty-two (32) hours at three different clinical sites and submit a
 Radiography Observation Verification Form. Please note specific
 guidelines on the observation validation form for completing this

- requirement. Additional hours may be observed to obtain additional admission points. (Click here to see Admission Scoring form for more details.)
- Accepted applicants will be required to submit to a criminal background check facilitated by MTC and conducted by The Ohio Bureau of Criminal Identification and Investigation. This background check will include, but is not limited to, an analysis of fingerprints and review of prior criminal records. Any criminal record, including felony and misdemeanor convictions as well as drug related arrests will prohibit student from admission into the program. The submission of any false information to MTC shall be cause for immediate dismissal from the.
- Potential employers for MTC Health Technology Programs may require criminal background investigations as conditions for employment. Any criminal background may preclude an individual from employment. Therefore, completing a MTC program does not guarantee future employment.
- Accepted applicants will be required to submit to an eight-panel drug screen. In addition, students will be subject to random drug screens.
 Students who refuse/fails to cooperate will be considered "positive".
 Unsatisfactory/positive results of the drug screen will result in ineligibility for admission and/or continuation in the program.
- If applicable, current MTC students seeking Radiography admission must have a minimum 2.5 GPA. Application deadline for each class beginning in the summer is **April 1st**. Students will be admitted into the program based upon an admission point system, whereby the most qualified applicants are considered based upon highest point totals. Class size is limited to the availability of clinical sites.

 Only completed applications submitted by the application deadline
 will be considered.
- Applicants will be notified of their status in the program by mail approximately 6-8 weeks after the application deadline.

- Applicants who are not selected into the program, but would like to be considered for a future class, will need to complete another program application.
- Transfer students to MTC must qualify in accordance with current Radiography Program admission criteria.
- If required, College Foundation Courses are available to help you meet any specialized program admission requirements.
- Clinical sites as well as potential employers may require drug screens and criminal background investigations.
- The Radiography Program begins once a year each Summer term.
